

POLIS MEMBERSHIP CONDITIONS

GENERAL

Membership shall be granted upon approval by the POLIS Management Committee. All requests for membership can be sought by written application to the POLIS Secretariat in Brussels. The written application must be made on a standard application form and be accompanied by a letter of intent of the local authority.

The membership fee is due within 4 months from the date of sending and 5% discount applies for the members that pay the corresponding fee by April 30th (*).

Members wishing to resign from POLIS are required to pay the membership fee in full for the year of resignation.

FULL MEMBERSHIP

Full membership is opened to European cities, regions and regional organisations with the character of local authorities, also outside the European Union, with a democratically elected government, to all local public transport corporations having their registered offices in Europe, and to all European local or regional transport authorities.

ASSOCIATE MEMBERSHIP

Associate Membership is open to entities which are not eligible for full membership such as non-European cities and regions, associations, research centres and universities with an interest in local and regional transport. Associate members do not take part to POLIS internal decision making process and do not vote at the General Assembly.
