### Entrant Eligibility

The contest is open to entrants aged 18 years or over at the time of the submission of their image, excluding anyone professionally connected with the contest, CIVITAS SUMP<sup>s</sup>-Up, the European Commission, Eltis, or the SUMP Guidelines Editorial Board.

### Contest theme and prize

Show sustainable urban mobility in action in your town or city! The winning photo will be used as the front cover image of the updated edition of the EU SUMP Guidelines. There are no cash or other alternative prizes available in whole or in part.

Ideally, images will depict dynamic scenes of different transport modes mixing together in urban environments – the greener, safer and more sustainable the better! All entries should be sent to [contact@sumps-up.eu](mailto:contact@sumps-up.eu).

### Specifications for submitted photos

The photo(s) must be submitted as a high-resolution image – ideally as high as the device used to take the photo will allow. A minimum of 300 DPI is sought for all images.

The photo must be an original creation. Contestants warrant that the photos contain no copyright materials, are their original works, have not been copied, in whole or in part, from any third party, and that they have full authority to grant these copyrights.

The participant must certify and warrant that the submitted photo(s) do not infringe the rights of privacy/publicity or intellectual property rights of any person or entity.

CIVITAS SUMP<sup>s</sup>-Up is not responsible for intellectual property violations that might have resulted through the submissions of photos.

The photo must be taken within a [Member State](#) of the European Union, the [European Economic Area](#) or one of the [Associated Countries](#) of the Horizon 2020 programme.

Photos should also in no way promote reckless mobility. That is the use of travel modes in a dangerous manner considering the circumstances.

# CIVITAS SUMP's-Up Photo Competition

### *Driving and cycling (and other participant operated vehicles)*

The participants' actions fall below the standard expected of a reasonable and competent driver, cyclist, etc., including:

- Going too fast for the conditions;
- Operating a car/bicycle whilst tired or under the influence of alcohol or drugs;
- Having too many passengers (e.g. more than the vehicle is designed to carry);
- Cutting in and out of traffic;
- Engaging in another activity whilst the vehicle is moving, such as using a mobile phone, reading something, or taking out and lighting a cigarette;
- Overtaking on the inside;
- Driving inappropriately close to another vehicle;
- Driving through a red light;
- Emerging from a side road into the path of another vehicle;
- Driving a dangerous vehicle (i.e. an obviously unfit vehicle, e.g. a car or bike with bad brakes or no night-time visibility).

Although bicycle helmets are not mandatory, we favour images of cyclists who are wearing bicycle helmets as they act as a good role model.

### *Pedestrians*

They should not behaving in a manner that puts themselves or others at risk, e.g. crossing red lights, crossing in the middle of the road instead of at a proper crossing, being intoxicated, or looking at their smart phone instead of at the road/street.

In addition, photo must not contain violence, profanity, sex or direct attacks on individuals or organisations. Any entries deemed offensive will be immediately disqualified.

Any content showing any person under the age of 16 must be submitted with prior parental or legal guardian consent. The CIVITAS SUMP's-Up team reserves the right to contact a contestant for further clarification and verification if deemed necessary.

All photo contest entries with an identifiable person or persons must be accompanied by a model release.

## Judging the photos and notification of the selected photographers

After the contest closes on **6 March 2019, 18.00 CET** (Central European Time), qualifying photos will be judged based on clarity, composition and overall presentation.

The winner will be decided on by a jury consisting of members of the CIVITAS SUMP's-Up project team, the European Commission's Directorate-General for Mobility and Transport, the Eltis consortium, the Innovation and Networks Executive Agency of the European Commission, and the SUMP Guidelines Editorial Board.

The person whose photo is selected to be used on the front cover of the EU SUMP Guidelines will be notified by e-mail.

Any attempt by a participant to influence the result or subvert the photo competition will lead to their immediate disqualification.

If an entrant cannot to be contacted after reasonable attempts have been made to do so, CIVITAS SUMP's-Up reserves the right to award the prize to the next best entry.
