

#### **AVP WHAT: Realising the CUSTOMER JOURNEY**



1. Set Up Set up an account and learn about AVP and additional services like EV charging.



2. Before & While Driving Check AVP and services availability, and find and reserve a parking spot.



3. Arriving Arrive at the parking facility and navigate to the drop-off zone.



4. Start Transaction Start automated valet parking handover vehicle to infrastructure at the drop-off zone.



5. During drop off and pick up Utilization of additional services. No intervention of the driver.



6. End transaction Driverless handover of the vehicle from infrastructure to driver.



7. Service Information Get payment information and monthly invoice for parking and additional services.



8. Customer Loyalty Receive updates and communications, and benefit from promotions.
